Dear Chief:

We have recently received notification from the U.S. Forest Service that the Volunteer Fire Assistance program was funded for fiscal years 2025-2026. As in the past, the Volunteer Fire Assistance program makes funds available to volunteer fire departments (VFDs) in **communities with populations of 10,000 or less** for organizing and equipping local forces. The program is managed by the West Virginia Division of Forestry (WVDOF) which provides guidelines and priorities in compliance with Federal regulations. This program will allow the WVDOF to match equipment project costs to qualifying Volunteer Fire Departments (VFD) on an 80/20 basis.

As federal grant monies are limited, the WVDOF must establish priorities based on individual department need, type of equipment requested, and the service value of the project to the community. Additionally, the fund limitations require WVDOF to cap the amount of match money granted at \$2,000 per VFD (see guidelines below).

**General guidelines for the 2025/2026 Volunteer Fire Assistance program are:**

1. No more than \$2,000 will be allocated to any one department.
  - a. Example: Project cost total = \$2500
    1. VFD 20% = \$500
    2. WVDOF 80% = \$2000
  - b. The department must make the initial purchase upfront and submit an invoice for reimbursement.
2. The WVDOF **cannot** reimburse purchases made prior to application approval.
3. Requests for building rehabilitation, new construction or the purchase of vehicles will **not** be considered. Vehicles include any type of ATV.
4. However, applications for equipment needed to outfit a vehicle **will** be accepted.
5. Project requests pertaining to equipment must be for items that will

improve the operation of the fire department. Normal maintenance items are **not** eligible.

6. Although this program provides funds for both structural and wildland fire activities, applications for equipment relating primarily to wildland fire suppression will be ranked higher than those relating solely to structural fires.
7. The following state guidelines apply to any individual equipment items with an **acquisition** cost of **\$1000 or more**:
  - a. A Volunteer Fire Assistance tag must be affixed to the item
  - b. Equipment cannot be sold or otherwise disposed without permission of the WVDOF
  - c. Item information must be added to the Memorandum of Understanding for state property
  - d. Equipment will be inspected periodically by WVDOF personnel
8. Your approved project must be completed, and invoices submitted to this office by **September 30, 2026**.

If your organization is eligible and wishes to apply for funding under the Volunteer Fire Assistance program, please fill out the attached Application and provide a **written description and cost estimate** of your project. We will then evaluate the application and notify each applicant of their status. **Applications must be postmarked or emailed received no later than January 31, 2026. Applications postmarked after January 31, 2026 will not be accepted – no exceptions.** We will notify you of approval or disapproval of the request as soon as all the project evaluations are completed.
